

▲ May 9<sup>th</sup>

GSTHW passes [Motion 22 from Tikanga Pasefika](#). Since then, DoP has engaged a series of talanoa around how it deals with minority groups in the Diocese. 6 talanoa sessions have been engaged in the various arch-deaconries and episcopal units in 2018.

● May 16<sup>th</sup>

Abp Philip and Bp Justin meet with key Christchurch leaders (Fellowship of Confessing Anglicans) as they consider their response

● May 2018 – Jan 2019

Abp Philip participates in a series of meetings with those who wish to leave ACANZP, multiple resignations received in ChCh

■ Jun 12<sup>th</sup>

Abp Philip [writes an update to Archbishop of Canterbury](#) and attaches recent exchanges with Australian Bishops

Jul 18<sup>th</sup>

[Pension Board letter to Bishops](#) – will recognise same sex spouses


